AGING SERVICES

Services for senior adults aged 60 and older, their caregivers, and grandparents raising grandchildren. Aging services are listed on the first 9 pages by county and are accessed through the nutrition sites, which are indicated as a “focal point.”

Case Advocacy and Support - case managers assess for eligibility and coordinate care for frail senior adults and grandparents raising grandchildren.

Congregate Meals - meals provided in congregate settings, such as senior centers & restaurants.

Counseling is for senior adults, their caregivers, and grandparents raising grandchildren. Helps them cope with stress and depression.

Elder Abuse - investigation and help for adults aged 60 and older when abuse is suspected.

Family Caregivers Support - information and help to access services for caregivers of senior adults and grandparents raising grandchildren. Services include counseling, training, support groups, in-home respite care, and gap filling services.

Health Screening - blood pressure and sugar checks and other health screening programs.

Home Delivered Meals - meals delivered to homebound senior adults.

Home Modifications - adapting the structure of a home to meet the physical need of frail seniors.

Homemaker - housekeeping, errands, supervision in the home.

In-Home Respite Care - temporary, substitute care or supervision for frail senior adults in their home to give the caregiving spouse or family member a break.

Information & Assistance - provides senior adults, their caregivers, and grandparents raising grandchildren with information about services and help to apply.

Legal Assistance - advice, education, and help with most legal matters.

Medication Management - education and assistance to prevent incorrect medication.

Outreach - social service workers go to homes and community facilities to inform senior adults, their caregivers, and grandparents raising grandchildren about services.

Long Term Care Ombudsman - helps senior adults in assisted living facilities and nursing homes.

Transportation is to and from community facilities, usually in buses and vans.

The following Aging services may not be available in every county:

Adult Day Services - care and supervision of frail senior adults in a community center for a portion of the day. Used as a break for caregiving spouses and family members.

Assisted Transportation - escorts senior adults to and from community resources.

Community Care in Residential Settings – affordable housekeeping, meals, and personal care of frail senior adults in an apartment building with 24 hour staffing.

Senior Companion - help, support, and companionship to senior adults in their home.

PROGRAM ELIGIBILITY GUIDELINES

Limits change in January for these programs:

Medicare, Part A - Hospital deductible for first 60 days is \$1,100, days 61-90 is \$275 per day, and days 91-150 is \$550 per day.

Skilled nursing facility deductible for first 20 days is \$0 and days 21-100 is \$137.50 per day.

Medicare, Part B - Premium is \$96.40 per month for most beneficiaries. Deductible is \$155 Co-pay is 20% of Medicare-approved charge after the deductible is met.

Medicare Part D - Deductible is \$310, beneficiary pays all costs when drug costs exceed \$3,610. Catastrophic coverage begins when drug costs exceed \$6,440.

Prevention of Spousal Impoverishment - spouse at home keeps up to \$2,739 income per month and \$109,560 of assets.

Institutionalized spouse keeps up to \$30 of income per month and \$2,000 of assets. Apply at Dept. of Human Services.

Social Security - under age 65, \$1 of benefits withheld for each \$2 of wages earned over \$14,160. Ages 65 and over, no limits.

SSI - Supplements income. Up to \$674 per month for 1 person (\$2,000 assets) and \$1,011 for 2 (\$3,000 assets). Apply at Social Security.

Limits change in March for these programs:

Medicaid - Medical card. Monthly income limit is \$928 for 1 person (\$2,000 assets) and \$1,239 for 2 (\$3,000 assets). Apply at Dept. of Human Services.

QMB - Pays Medicare premiums, deductible, and co-pay. Monthly income limit is up to \$928 for 1 person (\$4,000 assets) or up to \$1,239 for 2 (\$6,000 assets). Apply at Dept. of Human Services.

SLIB - Pays Medicare Part B premium. Monthly income from \$928 up to \$1,108 for 1 person (\$4,000 assets) or \$1,239 up to \$1,482 for 2 (\$6,000). Apply at Dept. of Human Services.

QI-1 - Pays a small portion of the Medicare Part B premium. Monthly income between \$1,108 up to \$1,243 for 1 person (\$4,000 assets) or \$1,482 up to \$1,664 for 2 (\$6,000 assets). Apply at Dept. of Human Services.

Limits change in July or late summer for these:

Community Care Program - Homemaker & Adult Day Services. Co-pay if monthly income is above \$903 for 1 person and \$1,215 for 2. Asset limit is \$17,500. Apply with Dept. on Aging.

Illinois Farmers Market Coupons - coupons to buy fresh food and vegetables at area Farmers Markets for people age 60+. Monthly income limit is \$1,670 for 1 person and \$2,247 for 2.

Illinois LINK Card - Assistance buying food. Monthly income limit is \$1,127 for 1 person and \$1,517 for 2. Asset limit is \$3,000 if age 60 or older (\$2,000 otherwise.) Apply at Dept of Human Services.

Energy Assistance (LIHEAP) - Helps with heating. Monthly income limit is \$1,300 for 1 person and \$1,750 for 2.

Weatherization Program - winterizes the home. Monthly income limit is \$1,300 for 1 person and \$1,750 for 2.

Limits rarely change except as noted:

Circuit Breaker- Property tax grants and reduced fee for license plates. Annual income limit is \$27,610 for 1 person, \$36,635 for 2, and \$45,657 for 3 or more.

General Homestead Exemption is in addition to the exemption below and allows a reduction of up to \$6,000 in assessed value of your home in which you own and live in Illinois (for taxpayers of any age).

Illinois Cares Rx Pharmaceutical assistance. Annual income limit is \$27,610 for 1 person, \$36,635 for 2, and \$45,657 for 3 or more

Senior Citizen Homestead Exemption - \$4,000 exemption off assessed value of home. Must be aged 65 or older and live on the property. Apply at the county assessor's office.

Senior Citizens Assessment Freeze Exemption - Freezes the assessed value of home. Income limit is \$50,000 per year. Owner must be age 65 or older, live in the home, and pay taxes on the property. Apply and renew annually at county assessor's office.
